Important Updates, Reminders, & Deadlines

Home Sponsors Only - Important Claim Procedural Update

Beginning in April 2025, Daycare Home Claims will now be processed on Tuesday mornings that all CACFP vouchers are posted, provided the Sponsor Claim(s) are in "Approved" status. CACFP vouchers are typically posted the first four Tuesdays of each month around 8 am. 60-day deadlines for each monthly claim are detailed in the Claims tab of KN-CLAIM.

CACFP Sponsoring Organization Annual Financial Review

All Sponsoring Organizations (sponsors with more than one site) are required to have a CACFP Financial Review conducted annually. Sponsors that are scheduled for an Administrative Review will have this financial review in conjunction with the Administrative Review. Sponsoring Organizations that are not scheduled for an Administrative Review this year will have a stand-alone CACFP Financial Review. This review may be conducted as a desk review or conducted on-site. The reviewing consultant will send out communication to schedule this review.

Request to Use Electronic Transactions in Child Nutrition Programs

Sponsors who plan to use an online Enrollment & Income Eligibility Form or accept electronic signatures on any child nutrition form must complete the Request to Use Electronic Transactions in Child Nutrition Programs form available at https://cnw.ksde.gov under SNP, SNP Food Service Facts, Chapter 7. The Request to Use Electronic Transactions in Child Nutrition Programs form must be completed annually and returned to CNW at cnw@ksde.gov. Summer Food Service Program (SFSP)

Summer meal programs are designed to fill the nutrition gap that occurs in summer and make sure children can get the nutritious meals they need. Summer Food Service Program (SFSP) Outreach

If your Sponsor does not have SFSP sites, consider sharing a link to the site locator tool with families. This would allow families to find a location to receive free meals at sites across Kansas. The site locator tool is available at https://cnw.ksde.gov under SFSP, SFSP Locate a Site Near You.





Various texting services and hunger hotlines are also available. The automated texting service that connects families to local summer meal sites is 914-342-7744. Individuals can text a question that contains a keyword such as "food" or "summer meals". Parents and caregivers can also text the word "food" or "comida" to 304-304 to find the nearest meal sites through the No Kid Hungry Hotline. The USDA National Hunger Hotline number is also available – individuals can call 1-866-3-HUNGRY or 1-877-8-HAMBRE to speak with a representative who will find food resources such as meal sites, food banks, and other nearby social services.

2025 Farm to Plate Subgrant - Application Deadline is April 30

Child Nutrition Program (CNP) Sponsors may request up to \$9,500 to support Farm to Plate initiatives that will increase the local foods served as part of Child Nutrition Program snacks and meals. Subgrants will be utilized by CNP operators to advance eligible local foods programming activities. Subgrants will be available to School Nutrition Program (SNP), Child and Adult Care Food Program (CACFP), and Summer Food Service Program (SFSP) sponsors.
