Claim Deadlines for State Fiscal Year End – Important!

Summer Food Service Program (SFSP) May Claims submitted and in "Approved" status by 8:00 a.m. Tuesday, June 10, will be paid and money deposited on Friday, June 13. June claims won't be paid until the state accounting system re-opens in July with anticipated direct deposit being Friday, July 11. SFSP vouchers will then be processed typically the first three Tuesdays of each month as warranted. SFSP Reimbursement Claim Submission Deadlines

Original and upward revisions are due within 60 days of the end of the claiming month:

- May claim by 07/30/2025
- June claim by 08/29/2025
- July claim by 09/29/2025
- August claim by 10/30/2025

Reminders

- Sponsors serving summer meals must complete renewal and be approved before operations may begin.
- Make sure to update site applications if meal service times and dates change. Notify your consultant of any changes made to the site application so that changes can be approved as quickly as possible. We want to make sure that site information is available for the CNW and USDA meal site locator maps.
- If adult meals are served, sponsors must charge at least the full cost of the meal (including food and non-food supplies, labor, and the value of USDA foods).

SP 11-2025, CACFP 09-2025, SFSP 05-2025: Using Federal Funds to Purchase Local Foods

The purpose of this memorandum is to remind schools, sponsors, and institutions participating in any U.S. Department of Agriculture (USDA) Child Nutrition Program (CNP), including the National School Lunch Program (NSLP), School Breakfast Program (SBP), Fresh Fruit and Vegetable Program (FFVP), Special Milk Program for Children (SMP), Child and Adult Care Food Program (CACFP), Summer Food Service Program (SFSP), and the Seamless Summer Option (SSO), of the many ways they can purchase local foods to serve in Program meals. Sourcing and serving locally grown foods, and other farm to school activities, such as taste testing, gardening, and agriculture education, can infuse new energy and vision into CNP operations, support community health, create new opportunities for American farmers, invest Federal dollars in local economies, and strengthen strategies to encourage healthy choices. SP 13-2025, CACFP 10-2025, SFSP 06-2025: Full-Year Continuing Appropriations and Extensions Act, 2025: Effect on Child Nutrition Programs

On May 14, 2025, FNS released SP 13-2025, CACFP 10-2025, SFSP 06-2025: *Full-Year Continuing Appropriations and Extensions Act, 2025: Effect on Child Nutrition Programs*. Consistent with the guiding principles regarding nutrition programs identified by U.S. Department of Agriculture (USDA) Secretary, Brooke Rollins, to clarify statutory, regulatory, and administrative requirements, this memo provides guidance from the Full-Year Continuing Appropriations and Extensions Act, 2025 (Public Law 119-4). SUN Bucks 2025

SUN Bucks, also known as Summer EBT, is a program to help families buy food for their school-aged children during the summer. Families will get a one-time benefit of \$120 per year for each eligible child to help buy groceries during the summer months. Children who get SUN Bucks can still participate in other summer meal programs. Receiving SUN Bucks will not affect children or families' immigration status. For families who were pre-approved in January or applied and received a notice of approval since the application opened, benefits were recently distributed as follows (based on the primary applicant's, not the child's, last name): May 28 – A to G, May 29 – H to M, May 30 – N to S, May 31: T to Z. The one-time \$120 benefit per eligible child was put onto a new or the household's existing EBT card. For those that have not yet applied, the SUN Bucks application is available until 5 pm on August 29, 2025. Visit SUNBucks.dcf.ks.gov for more information.
