Claim Deadlines for State Fiscal Year End – Important!

Summer Food Service Program (SFSP) May Claims submitted and in "Approved" status by 8:00 a.m. Tuesday, June 10, will be paid and money deposited on Friday, June 13. June claims won't be paid until the state accounting system re-opens in July with anticipated direct deposit being Friday, July 11.

SFSP Annual Administrative Training – Complete by May 15, 2025

Non-Congregate Meal Service in Rural Areas Training – Complete by May 15, 2025

If your sponsor is planning to offer non-congregate meals through the Summer Food Service Program (SFSP) or the Seamless Summer Option (SSO) in summer 2025, at least one sponsor representative must attend the Non-Congregate Meal Service in Rural Areas Training. Non-Congregate Summer Meals and Childcare

Question #1: Is it permissible for a childcare provider, such as a day care operator or childcare center operator, located in a rural area to collect meals for the children who attend their childcare services?

Answer #1: No, childcare providers cannot collect Program meals on behalf of parents or guardians for children attending their childcare. Childcare providers who care for whole groups of unrelated children formally enrolled in their care should not be considered guardians under the State agency's definition. Allowing a childcare provider to collect and distribute meals on behalf of groups of children introduces significant integrity risks, especially concerning meal duplication, ensuring meals reach eligible children, and food safety risks during transportation, storage, or distribution.

Question #2: Is it permissible for a childcare provider, such as a day care operator or childcare center operator located in a rural area, to take the children in care to a summer meals site to collect one or more meals?

Answer #2: The children present could get one meal, but not multiple days' worth of meals. The provider isn't a legal guardian, so they cannot receive the meals with children in their care and take them back to the childcare home or center to distribute. It would not be allowable for the summer meals site to give the children multiple days' worth of meals while in care because the provider would be responsible for storing them. Allowing a childcare provider to collect and distribute meals on behalf of groups of children introduces significant integrity risks, especially concerning meal duplication, and ensuring meals reach eligible children whether during their care or getting them to the parent/guardian to take home.

*In cases where children in childcare settings could benefit from non-congregate meals, they should explore the feasibility of becoming summer meal sites or participating in the Child and Adult Care Food Program (CACFP) to support meals for children in their care.

SUN Bucks 2025

SUN Bucks, also known as Summer EBT, is a program to help families buy food for their school-aged children during the summer. Families will get a one-time benefit of \$120 per year for each eligible child to help buy groceries during the summer months. Children who get SUN Bucks can still participate in other summer meal programs. Receiving SUN Bucks will not affect children or families' immigration status. If a child's household did not receive a letter from DCF in January 2025 regarding SUN Bucks eligibility, they can apply through the DCF self-service portal at dcfapp.kees.ks.gov. Applications for 2025 SUN Bucks must be submitted no later than 5 pm on August 29, 2025. The SUN Bucks benefit distributions expected to begin in mid to late April 2025 have been delayed. An updated distribution timeline has not been determined, but updates will be provided on the DCF website and Facebook page - @KansasDCF.
